

Step 1Remove fuel line bracket (A), disconnect and remove two the (2) bolts securing glow plug controller to controller bracket (B).



Step 2
Remove glow plug control module heat shield's (2)bolts.

Step 3

Remove the (4) bolts securing the glow plug control module.

Step 4

Remove glow plug module.

Step 5

Remove the factory valve from the fuel rail with an 18mm wrench. Transfer O-ring, lubricate threads and sealing surface with petroleum jelly. Reinstall with the race fuel valve and torque to 72 - 74 ft. lbs.

Step 6

Re-install brackets, heat shield, glow plug controller module and reconnect glow plugs.
